

Transcribed from the 19th Century Church Meeting Minutes held at Hampshire Records Office, Winchester by Rebecca Gabzdyl of East Boldre Community Stores Limited As part of a heritage project associated with the former Baptist Chapel's change of use to a community shop in 2023



In the month of March 1810, the Reverend William Giles, pastor of the Baptist Church at Lymington, with Messrs Benjamin Shepherd and David Dori paid a visit to two or three friends at this place, after repeated invitations, when Mr. Giles was requested to preach, and application was made to Mr. Isaac Tinsley, a very pious man for leave to preach in his house, which after a little consideration, was complied with when Mr. Giles preached on the conversion of Lydia, which proved so pleasing and edifying that he was requested to come again the following week. Which he did. And from thence the good work went forward by having frequently preaching on weekdays and regularly on Lord's days, either by Mr. Giles or two or three friends, members of the same church.

When the house became too small, friend Phillips kindly lent his barn for a few weeks, but as it would be wanted for his own use at harvest, and the congregation continued to increase, and several persons were awakened, it was judged proper to try to get a house built for divine worship, but some difficulty arose about procuring a suitable piece of ground for the purpose, when providentially Captain Thomas Perry being at Lymington at that time, who on being informed of the circumstances, and that there was a house to be sold with a garden, conveniently sited for the purpose voluntarily engaged to buy



it, which he did, and gave the land to build it on, and by the assistance of friends here, and the generosity of friends at Lymington and Mr. Giles going a begging for it, a house was built and furnished with a pulpit and forms. The size of it is 34 feet by 17.

And on the seventh of August was appended by Mr. Giles, who preached from Luke 11.2 Thy Kingdom come and Mr. Welch then of Newport but now of Newbury from Psalms 84.1 - How amiable are thy courts.

From thence it was supplied nearly as before for seven years without one disappointment, much good was done, many experienced the power of Divine Truth, confessed their faith in the Lord Jesus, as the only Saviour, and joined the church at Lymington and continued in communion with it till the year 1817 when, Mr. Charles being about to leave the church, it was thought expedient for the members here to unite into a separate church, which was affected on Monday the 24th of October when twenty of the above members were united into a Gospel Church state, being respectfully dismissed from the church at Lymington for that purpose. The solemn and important service was conducted in the following manner. Brother David Dore began in prayer, then Mr. Giles spoke on the subject before us and asked the members if it was now their wish and desire to be formed into a church, which was answered in the affirmative. Mr. Giles then read the letter of dismission as follows:

The Church of Jesus Christ at Lymington, baptised on a profession of faith in the Lord Jesus To certain of their fellow members meeting for divine worship at Beaulieu rails, sendeth Christian salutations.

Mr. Giles after making a few pertinent remarks on the nature and constitution of a Gospel Church, read the rules of the Mother Church and asked if they were willing and inclined to adopt them for their conduct, which was answered in the affirmative.

He then pronounced them a regular constituted Church of Christ. Mr. Clay then prayed for a blessing to attend the solemnities of the day, that they may become a very happy and flourishing people, that brotherly love may evermore reign amongst them, and that the glory of God may be promoted by them.

Mr. Giles then addressed the new formed church, pointing out their duty to God and to each other, and the privileges to be enjoyed by the people of God and concluded in prayer. It had been previously fixed for Mr. Clay to supply them once a fortnight as a probationer.

Then follow the rules alluded to above.







A church meeting after the afternoon service when the following statement was read and approved and ordered to be sent to Mr Tilley, Fraton?

The Gospel was first introduced into the lower part of Beaulieu Rails by the late Mr Mursell then minister of the 2nd Baptist church of Lymington and his deacon late Mr B Shepperd aided by Mr W Drawbridge and others on or about the year 1803.

Mr Mursell generally preached in a barn in this neighbourhood once a fortnight and the late Mr M Penny and later Mr James Chapman occasionally.

Circumstances took place which prevented Mr Mursell going so often as desirable consequently it was supplied by the late Rev J Dorris? then pastor of the independent congregation of this town.

After some time the two Baptist churches of Lymington united under the pastoral care of Rev William Giles consequently Mr Mursell was again at leisure and the people not equally supplied they applied to Mr Mursell to visit them again.

He made known the people's request to the Independent friends and expressed his willing help to supply the people but the deacon of the Independent church waited upon Mr Mursell to acquaint him that in

The Baptists were immediately stirred up and a place was soon opened for divine service near the village of Beaulieu under the direction of a society formed for promoting village preaching in our immediate neighbourhood by Mr Giles and other friends and about this time 2 friends joined us from the Independents (i.e. Messrs J Rutter and James Dore).

The villages around us were well supplied, Beaulieu Rails particularly so by Mr Giles, the late Mr D Dore (many years deacon of the Baptist Church), Mr Rutter, Mr J Dore and others.

The word was much blessed. Many being let out of darkness into marvellous light, thus it pleased God to honour the labours of his servants and many were baptised by Mr Giles and united to the church under his love.

About the year 1810 a meeting house was built and opened 7th August. Mr Giles and Mr Welch engaged?

In the year 1817, 20 of these friends were formed into a church being dismissed from the Lymington church which took place October 24th. Mr Giles and Mr D Dore conducted the services.

From this time until they had a pastor they were supplied by Rev Mr Millard, Mr D Dore, Mr Clay, Mr Rutter and Mr James Dore and according to arrangement Mr Mursell preached every 1st sabbath day, Mr Millard administering the 2 ordinance other friends supply them occasionally and the church continued to increase.

The Rev J B Burt from Stepney College was ordained over them January 15th 1829. The Rev Messrs Watts Draper Turquand Price and Davis

Their place of worship is much enlarged with two galleries. The ministry of Mr Burt rendered very useful.

Mr Burt resigned his pastorate June 1833 and 16 members left with him.

The deacons immediately applied for any advice from their kind and past friend Rev Mr Millard and Mr J Dore and Mr Mursell Jnr - we requested to serve the people to which they complied and since Mr Burt's resignation, Mr Dore and Mr Mursell have laboured in their midst and at the church's request sanctioned by Mr Millard we have regularly administered the Lord's Supper.

Mr Millard baptises and the same day generally administers the supper and secures the baptised into the church.

It appears about 30 or 40 persons were baptised by Mr Burt.

Since Mr Burt left the attendance has been and is still very encouraging and up to the 16th September 1838 about 27 persons have been baptised by Mr Millard.


At a special church meeting the recent conduct of Thomas Phillips, namely drinking and fighting at a beer shop was taken into consideration and it was thought it would be for the glory of God to exclude him at once and he was excluded accordingly.

At the same time the following resolutions were unanimously agreed to.

It being considered desirable that a more diligent oversight be taken of the church and that on account of the number of members and the pastor living at a distance it is impossible for him to exercise that superintendence which is desirable.

It is resolved:

- 1) That some brethren be chosen to assist the pastor in that work under the name of Visitors
- 2) That for the purpose the neighbourhood be divided into districts. to each of which a brother be appointed whose duty it shall be to observe if there be any members residing in his district who neglects the house of God or any other christian duty, or lives in the practice of any sin; or if there be any sick or if there be any enquiring what they can do to be saved to visit such and make reports of the case to the pastor.
- 3) That the following be the districts:
 - a. Hilltop including Hartford. Visitor James Prince
 - b. The lower part of Beaulieu that with the roads leading to Hilltop and Pennerly. Visitor John Ward.
 - c. The upper part of Beaulieu that extending to Hatchett Gate and Bunkers Hill. Visitor Thomas Payne.
 - d. Bucklers Hard including Bouveries. Visitor William Bundy
 - e. Furzey Lodge extending to Hatchett Mill. Visitor Edward Gregory
 - f. From Hatchett Pond to the chapel. Visitor Joseph Kitcher
 - g. From the chapel to Monkish Town. Visitor Michael Kitcher
 - h. East End. Visitor Peter Miller.

A prayer meeting was held on the Tuesday afternoon and in the evening a meeting for reading the letters when addresses were delivered by Messrs Smith of Whitchurch and Room of Portsea. 


